Background:

Pursuant to a condition of Consent Application B037/16, the owner of 445 Carville Road was required to enter into a Grading Agreement with the Town of Richmond Hill. The Notice of Decision required that the owner dedicate the existing reserve block (refer to Map 1 for location) adjacent to the Petrolia Court road allowance as public highway.

Part of Block 8 (0.30 Reserve) on Plan 65M-4049, described as Part 4, on Plan 65R-37074, as shown on Map 2, forms the reserve adjacent to Petrolia Court. This reserve block will need to be established as public highway to form part of Petrolia Court in order to allow for legal access for the new lot fronting onto Petrolia Court

Financial/Staffing/Other Implications:

There are no financial or staffing implications arising from this report.

Relationship to the Strategic Plan:

The recommendation in this report demonstrates the strategic objective of building stronger connections with the community and our responsibility to serve as a role model for municipal management of our resources.
