### **Background:**

The David Dunlap Observatory (DDO) lands which includes the Observatory dome, Administration and Radio Shack Buildings was transferred into the Town buildings portfolio on March 21, 2017. This area is adjacent to Town-owned parklands and is part of the DDO Park Master Plan.

With the transfer, it was determined that the Town will manage and use the property consistent with the Town's Strategic Plan and policies and to ensure the site remains a public space. An Expression of Interest was subsequently conducted and staff are negotiating with third parties to enter into non-exclusive use agreements to facilitate the delivery of educational and public outreach programming.

While work is underway in accordance with the David Dunlap Observatory Building Conditional Assessment Report (SREIS.17.021), the Town is positioned to begin programming at the DDO.

With the transition to the Town's ownership, it is also important to develop a consistent brand so that the Observatory dome, Administration Building and park become recognized as a destination place. The use of a symbol will help to build public recognition and ensure a consistent look and feel of all promotional products.

### **Design Elements:**

Appendix "A" features two types of DDO designs: One with natural and astronomy features such as a tree, path, stars and moon. These additional elements are included as they reflect the future plans for the area. The other design features the observatory on its own. "Richmond Hill" is added to one version of each design. As the area transforms into a destination park, the association of the Town's name with the Observatory, Administration Buildings and park could help to increase tourism and expand the audience and denote ownership.

The designs incorporate colours and fonts and style elements that are consistent with the Town of Richmond Hill Branding Guidelines. For example, both the colour palette and a hill have been included in the options.

Once selected and approved, the symbol will be applied according to the Town's Branding Guidelines and where possible, accompanied by the Richmond Hill brand (see example in Appendix B).
