Subject: SRPRS.18.162 – Hidden Spring Burial Site –

**Cemetery Establishment** 

### **Purpose:**

The purpose of this staff report is to seek Council's approval to establish the existing cemetery known as Hidden Spring Burial Site.

# Recommendation(s):

- a) That the establishment of the existing cemetery known as Hidden Spring Burial Site, consisting of an area of 4.599 metres from east to west and 4.599 metres from north to south, and legally described on Plan 65R-31626 as Part 1 & 2, Part of Lot 11, Registered Plan 1931, Town of Richmond Hill, Regional Municipality of York, Province of Ontario (the "Hidden Spring Burial Site") be approved and be found to be in the public interest; and
- b) That the Mayor, Town Clerk and the Commissioner of Community Services be authorized to execute any documents as may be required to implement the establishment and maintenance of the existing Hidden Spring Burial Site.

### **Background:**

In August of 2008, the archeological consultant working on behalf of the Vogue Developments and Thornhill Village Estates subdivisions on Arten Avenue (D03-07001 & D03-07007 respectively) reported the discovery of an ancestral Huron-Wendat settlement, which included the remains of five persons along with numerous artifacts.

In order to pursue the D03-07001 subdivision, Thornhill Village Estates entered into a Site Disposition Agreement (dated September 12, 2008) with Six Nations of the Grand River pursuant to the Cemeteries Act. The Site Disposition Agreement describes an agreed upon process for removing, studying, temporarily storing and re-interring the human remains found at the burial site. With regard to re-interment, the agreement specifies the intent for the remains to be located within the "adjoining Park Block, or other location nearby approved by both the Town of Richmond Hill and Ms. Barb Harris [representative of the Six Nations of the Grand River]." The adjoining park block is Hidden Springs Parkette (see Attachment 1).

On February 17, 2009 Council agreed in principle to accept ownership of the First Nations Cemetery resulting from re-interment of the native remains within the adjoining park block (now known as Hidden Springs Parkette) (SRPRC.09.08). A Certificate of Consent to establish a cemetery known as the Hidden Spring Burial Site within the Town-owned Hidden Springs Parkette was re-issued by the Bereavement Authority of Ontario on May 14, 2018 (see Attachment 2). In order to complete the process, the certificate must be registered at the Ontario Land Registry Office. This report (SRPRS.18.162) seeks Council direction required to proceed with the registration of the cemetery and fulfill the agreement between Six Nations of the Grand River and Thornhill Village Estates. The proposed cemetery will occupy only a small portion of Hidden Springs Parkette (approximately 21.1 square metres). The burial location is shown on Attachment 3. There will not be any demarcation of the cemetery area within the park or any individual grave markings.

#### **Discussion:**

Registration of the cemetery and the actual re-interment of the remains are the remaining steps in the process to fulfill the requirements of the Site Disposition Agreement and finalize approvals for a small portion of the park to become a cemetery. The Six Nations of the Grand River plan to conduct a one-day ceremony to re-inter the remains in the near future.

## **Relationship to the Strategic Plan:**

Approval of the registration of the cemetery would be consistent with Goal Two of the Strategic Plan which is "A More Vibrant Richmond Hill". The cemetery will commemorate, honour and respect the remains of the earliest residents of the area.

#### **Conclusion:**

The registration of the Hidden Spring burial site as a cemetery is the final step in implementing the Site Disposition Agreement between Thornhill Village Estates and the Six Nations of the Grand River. The registration will provide for a registered formal cemetery
