Scheduled Business

3.1 Presentation by Neil Garbe, Chief Administrative Officer, regarding the prohibition of smoking or vaporizing of recreational cannabis in public places in the Town of Richmond Hill

Neil Garbe, Chief Administrative Officer, made a presentation regarding the prohibition of smoking or vaporizing of recreational cannabis in public places in the Town of Richmond Hill. He provided an overview of the Federal Legislation and status of the Provincial Cannabis Legislation, and highlighted the regulation options for Richmond Hill, namely, (i) remain status quo and use the current Federal and Provincial Legislative enforcement model in accordance with the *Smoke-Free Ontario Act, 2017*; and (ii) adopt a By-law prohibiting use in additional locations not covered by the legislation and provides for a system of fines. N. Garbe concluded the presentation by reviewing enforcement of the proposed By-law by York Regional Police and requested Council provide direction for the adoption of a By-law.

Delegations

Haiyan Jiang, 39 Alexandra Wood, addressed Council regarding the prohibition of smoking or vaporizing of recreational cannabis in public places in the Town of Richmond Hill. She advised of the variety of forms cannabis was available and noted the importance of preventing cannabis use among youth. She expressed her disappointment with the Province's adoption of Bill 36 and advised of her support for Council to adopt a By-law that would restrict smoking or vaporizing of recreational cannabis in public spaces in Richmond Hill.
