Equipment

Purpose:

The Fleet and Supplies Section is seeking approval to acquire parts and maintenance services for highly specialized equipment already in use at the Town.

Recommendation(s):

- a) That the sole source acquisition of parts, maintenance services including the purchase of ancillary attachments for highly specialized equipment be authorized pursuant to the Procurement By-Law #113-16, Appendix B, Part 1 - Sole Source Acquisitions, Section c) to ensure the compatibility with existing products to recognize exclusive rights such as patent, copyright or license, or to maintain specialized products that must be maintained by the manufacturer or its representative; and
- b) That the Chief Administrative Officer be authorized to execute any and all necessary documentation to affect the contract including any exercised optional term(s).

Background:

The Fleet and Supplies Section procures all non-emergency vehicles and equipment (assets) for the Town of Richmond Hill and its internal users. When assets are procured either through capital replacement or in conjunction with growth, the Town follows a competitive process to determine the preferred vendor. There are several circumstances when highly specialized assets have been acquired for specific maintenance objectives e.g., street sweeping that will collect litter, leaves and fine material; Elgin Eagle Mechanical Sweeper SRCS.15.43. Staff have found it challenging when procuring single/sole source services through an exclusive vendor or original equipment manufacturer (OEM) during the asset lifecycle. Once an asset is acquired, in many cases, the award includes provisions for parts and servicing over the asset life cycle due to exclusivity rights. In many cases, parts and services cannot be obtained other than through the OEM or its authorized, exclusive territorial dealers. In this case, the OEM becomes the sole source vendor. The table below identifies each manufacturer, distributor and the planned renewal term for the target asset lifecycle;

Financial/Staffing/Other Implications:

The estimated annual value of the sole source acquisition is \$380,000 for parts, maintenance services and related ancillary attachment purchases from the above list of manufacturers. The Town receives preferred pricing over MSRP.

These services are budgeted annually within the Public Works Operations operating budget and are included in the 5-year Fleet forecast.

Relationship to the Strategic Plan:

The sole source acquisition as identified in this report aligns with the Town's Corporate Strategic Plan, Goal Four – Wise Management of Resources in Richmond Hill through an ongoing commitment to responsible municipal management.
