9.1 Presentation by Chuck Thibeault, Executive Director, York, Central Counties Tourism, and Samantha Wainberg, Executive Director, York Region Arts Council, regarding an overview of tourism development

Chuck Thibeault, Executive Director, Central Counties Tourism, and Samantha Wainberg, Executive Director, York Region Arts Council, made a presentation to Committee to provide an overview of tourism development in the area.
