4.1 SRCFS.19.005 - 2019 Operating Budgets

David Dexter, Director, Financial Services and Treasurer, provided a status update regarding the 2019 draft Operating Budget. He reported on the impact of the recommendations from the February 12, 2019 Budget Committee meeting related to the elimination of the Director position and the Richmond Hill Public Library Board budget being capped at a 2.4% increase. D. Dexter identified items that were to be followed up on including final growth numbers for 2018 and 2019 forecast; quantifying the portion of Investment Income collected from Regional and School Board taxes; increase in the Seniors Tax Assistance Grant; and changes to the municipal tax bill. He concluded the status update by reviewing items to be considered at todays and the February 26, 2019 Budget Committee of the Whole meetings.
