He provided an overview of the future two-hospital model between Mackenzie Richmond Hill Hospital and Mackenzie Vaughan Hospital to provide community-based services; reviewed current hospital capacity and the interim solution put into place to address healthcare needs; and highlighted enhancements made at Mackenzie Richmond Hill hospital and their achievements. Mr. Stationwala reviewed the continued progress at Mackenzie Vaughan hospital, funding for Mackenzie Health, and noted that they are a proud member of Richmond Hill's Business Community. Mr. Stationwala extended an invitation to all to participate in the Strides For Stroke walk/run event to be held May 4, 2019, and advised Members of Council that hospital tours are available if interested.
