### **Background:**

In April 2017, Council approved an update to the Economic Development Strategy for Richmond Hill (SRCAO.17.09), to ensure that it reflects the current needs and aspirations of the community as well as the changing economic development landscape of the GTA and the province more generally.

For 2018, Richmond Hill's business community continued to demonstrate stability with a year-over-year job growth rate of 3.5%, and a ten year average annual business growth rate of 3.6%. The City is home to 72,020 jobs and 4,840 businesses as per the 2018 York Region Employment Survey.

The attached 2018 Economic Development Annual Report provides a general overview of several economic indicators from January 2018 to December 2018, which gives further insight into Richmond Hill's business community. It also outlines key highlights of some of the initiatives and projects that the Economic Development team delivered.

## Relationship to the Strategic Plan:

Implementation of the Economic Development Strategy supports all four goals of the Strategic Plan by: engaging the business community, supporting better options for working and doing business, supporting initiatives to make Richmond Hill one of the most liveable cities in the GTA, and by creating opportunities for improved live-work balance and serving as a role model for municipal management.

#### **Conclusion:**

The Economic Development Strategy provides the foundation for achieving Richmond Hill's long-term economic development vision of sustained economic growth built on innovation, investment, entrepreneurship, creativity, and quality of place.

Over the next year, staff will continue working on initiatives that are aligned with the Strategy and will seek new opportunities stemming from the rapidly evolving economic landscape to help achieve Richmond Hill's long-term economic development vision.
