2. Disclosures of Pecuniary Interest and General Nature Thereof

3. Minutes of Previous Meeting

3.1 Minutes - Heritage Richmond Hill meeting HRH#02-19 held May 7, 2019

4. Scheduled Business

4.1 SRPRS.19.113 - Removal of 880 19th Avenue from the Municipal Heritage Register - City File Number D12-14005

Committee members enquired about mechanisms in place to prevent alterations to a property that would result in the loss of cultural value, and whether a property could maintain cultural heritage value through other features. Staff advised that there was not a policy in place for the municipality to prevent changes to a property unless the property had been designated, or if a site plan application had been submitted allowing for staff comments and feedback.

General discussion ensued regarding the distance and visibility of the structure located at 880 19th Avenue from the road, and how the property does not have contextual value due to its location at the rear of the treed lot.

4.2 Property Designation Process - Overview by Joanne Leung, Manager, Urban Design, and Pamela Vega, Urban Design/Heritage Planner

P. Vega, Urban Design/Heritage Planner, provided an overview of the designation process for properties listed on the City's Inventory of Cultural Heritage Resources and the designation process for non-listed properties. She reviewed the four scenarios that initiate the designation process: Heritage Richmond Hill incentive, owner incentive, demolition application, and development application. P. Vega noted that the City conducted three to five Cultural Heritage Assessments (CHA's) each year for listed properties that had been identified by the Designation Sub-Committee, and explained that if a property had not been listed, owner incentive was the only option that would lead to designation.

Committee members discussed alterations to listed properties, the definition of a structure, and the completeness of the Inventory of Buildings of Architectural Historical Importance and how often it was updated.

General discussion ensued regarding the process of designating a heritage district within the municipality, the different programs in place within Richmond Hill to acknowledge and recognize heritage homes, and ways of educating residents about the heritage programs and incentives.

4.3 Role of the Heritage Richmond Hill Designation Sub-Committee and Appointment of Sub-Committee Members - Overview by Joanne Leung, Manager, Urban Design, and Pamela Vega, Urban Design/Heritage Planner

P. Vega, Urban Design/Heritage Planner, provided an overview of the role of the Heritage Richmond Hill Designation Sub-Committee, noting that the

Sub-Committee works with staff to identify three to five properties annually to be assessed. She reviewed the process followed by staff to narrow down potential properties to a shortlist for the Designation Sub-Committee to discuss and make recommendations on.

Committee members requested clarification on the anticipated time commitment of the Designation Sub-Committee members once appointed.

4.4 City of Richmond Hill's Heritage Plaque Program - Verbal Update by Joanne Leung, Manager, Urban Design, and Pamela Vega, Urban Design/Heritage Planner

P. Vega, Urban Design/Heritage Planner, provided an overview of the City of Richmond Hill's plaque program and the criteria for receiving a wooden plaque and a bronze plaque.

Committee members discussed the merits of historical properties having plaques on display, expressed an interest in reaching out to heritage property owners who do not yet have a plaque, and discussed ways of raising public awareness of the plaque program.
