Subject: Establish Lands as Public Highway, Block 121, 65M-4631, Menotti Drive. Related Files -B073/18, B078/18, and B079/18

Purpose:

To establish certain lands as public highway.

Recommendation(s):

That the following lands be established as public highway to form part of Menotti Drive:

Block 121, 65M-4631, designated as Parts 1, 2, and 3, 65R-38376.

Background:

As a condition of Consent Applications B073/18, B078/18, B079/18, the owner of 67 Puccini Drive was required to dedicate the existing reserve block (refer to Map A for location) adjacent to the Menotti Drive road allowance as public highway, in order to provide legal access to the property.

Block 121, Plan 65M-4631, designated as Parts 1, 2, and 3, on Plan 65R-38376 (illustrated on Map B) describe the reserve block adjacent to Menotti Drive. This reserve can now be lifted and should be established as a public highway to form part of Menotti Drive to allow access for the new lots fronting onto Menotti Drive.

Financial/Staffing/Other Implications:

There are no financial or staffing implications arising from this report.

Relationship to the Strategic Plan:

The recommendation in this report demonstrates the strategic objective of building stronger connections with the community and our responsibility to serve as a role model for municipal management of our resources.

Conclusion:
