### **Background:**

Rodeo Homes Richmond Hill Inc. have made Consent applications (B005/19, B006/19 and B007/19) to create three new lots which will have frontage onto Grey Alder Avenue. To facilitate this development, a land exchange has been agreed to between the City and Rodeo Homes as outlined in the related OMB Minutes of Settlement.

As a condition of the related Consents and Settlement, Rodeo is required to enter into a servicing agreement to construct municipal servicing for these new lots including improvements to the City Park. This agreement has been executed by Rodeo Homes and the timing is now appropriate to proceed with the land exchange.

After the land exchange is completed the new lots will not have access to a public highway. To ensure the new lots have public highway access the timing is now appropriate to establish Part 13 on Plan 65R-38514 as public highway to become part of Grey Alder Avenue.

# Financial/Staffing/Other Implications:

There are no financial implications associated with this report.

### Relationship to the Strategic Plan:

The recommendation in this report aligns with the Town's Official Plan and demonstrates the strategic objective of building stronger connections with the community and our responsibility to serve as a role model for municipal management of our resources.
