## **Background:**

Council typically adopts its annual meeting schedule for the upcoming calendar year in the fall of the preceding year. At the November 20, 2019 Council meeting, Council adopted revised Council meeting times based on a Member Motion of Regional and Local Councillor DiPaola. Council also removed Committee of the Whole from the meeting schedule.

### 2020 Meeting Schedule

The proposed 2020 Council meeting schedule is based on the meeting times approved at the November 20, 2019 meeting, the Procedure By-law 74-12 for Council Public Meetings, and a previously scheduled Budget Committee of the Whole meeting to consider the 2020 Operating Budget, as follows:

- Council meetings generally scheduled on the second and fourth Wednesday of each month commencing at 9:30 a.m.
- Council Public meetings generally scheduled on the first and third Wednesday of each month commencing at 7:30 p.m.
- Committee of the Whole meetings have been removed.
- Budget Committee of the Whole meeting scheduled on Tuesday, January 28, 2020 at 1:30 p.m.

In keeping with past practice, no meetings have been scheduled for the first two (2) weeks of January, the period that coincides with March Break, the month of August, and the last two (2) weeks of July and December. Additionally, where a statutory or civic holiday, significant faith holiday, or another event falls on any regular meeting dates, that meeting would be scheduled on an alternate date and/or time.

## **Meeting Holds**

Since 2012, a "meeting hold" has been included in the proposed meeting schedule to block off time in Councillor's calendars to facilitate additional meetings that may be required throughout the year. The meeting hold is a very effective tool for scheduling Steering Committees, Advisory Committees, Task Forces and/or Special Council meetings. Two meeting holds have been included for each month for 2020 on Tuesday's between the hours of 1:30 p.m. and 3:30 p.m. where feasible, excluding the months of January, March, July, August and December.

#### **Committees of Council and External Boards**

As other meetings for Committees of Council (Budget Committee of the Whole, Audit, etc.) and external boards (Richmond Hill Public Library Board) have been confirmed, the 2020 Council meeting schedule will be updated to reflect those.
