Subject: SRCFS.20.007 – 2020 BIA Proposed Budget

To present the 2020 BIA proposed budget and funding.

- b) That the amount of \$129,940 be levied upon the rateable properties in the improvement areas.

Background:

At the November 20, 2019, meeting Council approved the appointment of eleven (11) Directors to the BIA Board of Management. The new Board subsequently conducted two meetings to establish a proposed budget for 2020. Appendix "A" provides the detailed 2020 Proposed Budget and the following table summarizes this budget.

The responsibility of a BIA Board, in accordance to the Municipal Act, is as follows:

(1) A board of management shall prepare a proposed budget for each fiscal year by the date and in the form required by the municipality and shall hold one or more meetings of the members of the improvement area for discussion of the proposed budget.

(2) A board of management shall submit the budget to Council by the date and in the form required by the municipality and the municipality may approve it in whole or in part but may not add expenditures to it.

Financial/Staffing/Other Implications:

The 2020 amount of \$129,940 would be fully funded by a tax levy upon the rateable properties in the area, as part of the final tax billing.

Relationship to the Strategic Plan:

Presentation of the 2020 BIA Proposed Budget reflects the overall use and wise management of resources.

Conclusion:

The 2020 Proposed Budget of \$129,940 for the BIA is being recommended for approval with full funding from the tax levy on the rateable properties in the area.
