**4.2 SRPRS.19.199 - Demolition Request for 11575 Yonge Street - the former Jefferson Schoolhouse - City File D12-07486**

P. Vega, Urban Design/Heritage Planner, provided an overview of the information and recommendations contained in staff report SRPRS.19.199 related to the Demolition Request for 11575 Yonge Street, the former Jefferson Schoolhouse. She reviewed the history of the property including applications submitted to date; current use of the structure; and demolition application and Cultural Heritage Impact Assessment submitted in October 2019.

Committee members discussed their support of the staff report recommendations, and advised of their concerns with the information and evaluations contained in the Cultural Heritage Impact Assessment prepared by MW Hall Corporation for 11575 Yonge Street. Committee

members acknowledged the historical value and context of the Jefferson Schoolhouse, and expressed concern over the condition of the structure and what the municipality was able to do to maintain and protect it. P. Vega advised of the processes and mechanisms in place to protect heritage properties, and noted that the property owner had applied in the past for heritage grants. D. Kelly provided Committee with supplemental information related to the Jefferson Schoolhouse to support its value and historical significance in the community.

General discussion ensued regarding the feasibility of purchasing the Jefferson Schoolhouse or relocating it to another site. Committee members did not support the relocation of the Jefferson Schoolhouse as it would take away from the historical context of the building if it were to be moved from its original location, and were in agreement that the Jefferson Schoolhouse added character and enhanced the streetscape and surrounding development.
