Subject: SRPRS.20.029 – Amendment to the Building By-

law (By-law No. 55-19, as amended) respecting the appointment of a Chief Building Official and Inspectors pursuant to the Building Code Act

Purpose:

To consider an amendment to Building By-law No. 55-19, as amended, so as remove the appointment provisions of a Chief Building Official and inspectors pursuant to the *Building Code Act* and to enact a stand-alone by-law respecting these matters, including Council's delegation to the Chief Building Official to appoint inspectors.

Recommendation(s):

- a) That Council enact By-law No. 8-20, being a By-law to amend Building By-law No. 55-19, as amended, so as to remove provisions respecting the appointment of a Chief Building Official and inspectors pursuant to the *Building Code Act*; and,
- b) That Council enact By-law No. 9-20, being a By-law to appoint a Chief Building Official and inspectors pursuant to the *Building Code Act*, delegate Council's authority to appoint inspectors to the Chief Building Official and to set out a Code of Conduct for Building Officials.

Background:

The *Building Code Act, 1992*, assigns the responsibility for enforcement of the *Act* to Council. Further, the *Act* requires that Council appoint a Chief Building Official and such inspectors as are necessary for the enforcement of the *Act*.

Proposed Changes to the Building By-law

Building By-law No. 55-19, as amended, addresses matters related to the City's Building Code Program including submission requirements, permit fees, the appointment of the Chief Building Official and inspectors and their related Code of Conduct.

Staff changes occur from time-to-time that requires that Council enact amending bylaws to the Building By-law to appoint and/or remove inspectors pursuant to the *Act*.

Proposed by-law changes are the removal of the appointment provisions and related Code of Conduct from the Building By-law and for Council to enact a stand-alone by-law to appoint a Chief Building Official; delegate to the Chief Building Official Council's authority to appoint Inspectors; and, include within this stand-alone by-law the required Chief Building Official/Inspector Code of Conduct.

Council's delegation of the routine matter of the appointment of inspectors will eliminate repetitive Staff Reports and By-laws as staff changes occur and provide for immediate appointment/removal of inspectors upon their commencement of employment with the City or departure. Council will retain its authority to appoint the City's Chief Building Official.

The Chief Building Official will maintain a list of inspectors appointed and will provide a copy of this list to the City Clerk as it is amended/updated.

The proposed changes, including Council's delegation of the appointment of inspectors, are consistent with current municipal best practices and have been implemented in many municipalities including Brampton, Hamilton, London, Newmarket, Oakville, Oshawa and Vaughan.

Financial/Staffing/Other Implications:

The proposed changes will represent savings from an operational perspective.

Relationship to the Strategic Plan:

The administrative and enforcement roles of the City Building Division support the Strategic Plan Goals of Stronger Connections in Richmond Hill by maintaining a safe community.
