## **Background:**

The subject development has frontage on Hall Street with flankage on Wright Street, and is located west of Yonge Street as indicated on Map 1.

The existing sanitary sewer on Hall Street was extended in order to provide sanitary servicing for the townhouse site plan development, file D06-15040. The developer, Denham Custom Design and Build Inc. has requested that the external municipal sanitary sewer be assumed by the City.

Based on fulfillment of the conditions from the Site Plan Agreement as summarized in Appendix A, staff recommends assumption of the external municipal sanitary sewers associated with Site Plan File D06-15040.

# Financial/Staffing/Other Implications:

Upon assumption, the City will be responsible for the maintenance and operation of the aboveground and belowground municipal sanitary sewer. The annual maintenance cost is estimated to be \$1,488.

It is recommended that the Public Works Operations operating budget be increased by this amount during the next annual budget process to reflect these additional costs.

# **Relationship to the Strategic Plan:**

Assumption of municipal services demonstrates our responsibility to serve as a role model for municipal management of our resources.

## **Conclusion:**

Based on the above, staff recommends the assumption of the municipal sanitary sewer services as the conditions set out in the Site Plan Agreement have been fulfilled, Site Plan File: D06-15040.
