The Mayor called the meeting to order at 9:30 a.m.

There were no members of the public who addressed Council during the Public Forum.

### 3. Council Announcements

Councillor West wished everyone a Happy New Year and extended an invitation to all to attend the 52<sup>nd</sup> annual Richmond Hill Winter Carnival on February 1<sup>st</sup> and February 2<sup>nd</sup> at the Mill Pond Park, noting that there were new events scheduled to take place this year.

Councillor Muench wished everyone a Happy New Year and acknowledged those residents who have been impacted by area flooding.

Councillor Chan paid tribute to the victims and families affected by the Ukraine International Airlines Flight PS752 crash, honouring one of the victims who was a student at Adrienne Clarkson Public School, and requested that a moment of silence be observed in honour of the victims, their families, and all those affected by the tragedy.

A moment of silence was observed by all those in attendance.

Mayor Barrow echoed the comments made by Councillor Chan regarding the Ukraine International Airlines Flight PS752 crash noting the impact on the community, and extended heartfelt condolences to the victims, their families, and all those affected by the tragedy.

Councillor Muench further acknowledged the direct impact the Ukraine International Airlines Flight PS752 crash had on the Richmond Hill community, and noted the community vigils that were held to honour the victims and provide support to residents.

Whereas effective and efficient service may be better planned and delivered by consolidating Fire Services at the Regional level together with other first response services; and

Whereas administrative efficiencies may be gained on non-suppression fire activities such as training, education, dispatch, vehicle maintenance and inspections; and

Whereas York Regional Chair Wayne Emmerson supports Regional consolidation of Fire Services;

Now Therefore Be It Resolved:

- i) That York Region be requested to upload fire services for the purpose of consolidating Fire Services at the regional level;
- ii) That said action involve all York Region municipalities; and
- iii) That this resolution be forwarded to York Region and the other York Region local municipalities for support.
