1. Adoption of Agenda

2. Disclosures of Pecuniary Interest and General Nature Thereof

There were no disclosures of pecuniary interest by Members of Council under the *Municipal Conflict of Interest Act*.

3. Scheduled Business

3.1 Update on Richmond Hill's Response to COVID-19 - Presentation by Mary-Anne Dempster, Interim City Manager

Mary-Anne Dempster, Interim City Manager, provided an update on Richmond Hill's response to COVID-19, highlighting the work being done daily at the Emergency Operations Centre by the COVID-19 Task Force, and the numerous measures that have been taken to protect residents. She advised that through the use of different technology, Council meetings were able to continue in order to keep residents informed, and noted that different methods were being explored to conduct mandatory meetings and permit remote delegations going forward. M. Dempster reviewed actions being taken to protect staff and keep them updated, discussed how the regular business of the municipality was being maintained in a different way, and addressed economic development in the community and how staff were assisting

local businesses during this time of transition. M. Dempster concluded the presentation by providing Council with recommendations related to continued response to COVID-19 within the City of Richmond Hill for consideration.

- b) That the Clerk be authorized to establish and amend any and all protocols and procedures necessary to facilitate electronic delegations and public submissions at Council and Committee meetings during an emergency, and any such protocols and procedures are deemed to be part of Article 12 of the Procedure By-law 74-12 as amended;

c) That the Committee of Adjustment meeting scheduled for April 9, 2020, be rescheduled at the discretion of the Chair of the Committee of Adjustment; and,

d) That the Council Public Hearing tentatively scheduled for April 23, 2020 be cancelled.

3.3 Property Tax and Other Financial Relief - Presentation by David Dexter, Director, Financial Services and Treasurer

David Dexter, Director, Financial Services and Treasurer, provided an update regarding property tax and other financial relief within the City of Richmond Hill. He summarized the approved recommendations and direction given to staff at the March 25, 2020 Emergency Special Council meeting related to the deferral of property taxes, property tax initiatives at the provincial level, what has been requested from the Region of York, and what other municipalities have implemented to provide financial relief. He provided an update regarding tax collection methods, cash flow scenarios and contingency measures for the municipality, and water/wastewater rate and stormwater rate increase deferrals. D. Dexter concluded the presentation by providing Council with recommendations related to property tax and other financial relief within the City of Richmond Hill for consideration.

1. That the waiving of Penalties and Interest charges for late payment of taxes be extended to January 1, 2021 to assist those residents/businesses dealing with financial hardship related to the COVID-19 virus, and that residents/businesses who can afford to pay their taxes be strongly encouraged to do so at respective due dates;

- 2. That the approved Water/Wastewater retail rate increase of 7.5% for 2020 be deferred, subject to the Region deferring their wholesale rate increase;
- 3. That the waiving of Water/Wastewater late payment charges for overdue accounts, be extended to January 1, 2021;
- 4. That the approved Storm-water fee rate increase of 7.5% for 2020 be deferred to 2021; and

5. That the City's Returned Cheque Fee of \$45 be waived for the balance of 2020.
