Background:

In December 2004, Council approved By-law No. 258-04 for the establishment of the Disabled Parking Reserve. Annual allocation of \$50,000 from the disabled parking offenses revenue is made to this reserve to support mobility and accessibility initiatives in the City. The allocations to Richmond Hill Mobility Accessibility Foundation for the two prior years were as follows:

- 2018 was \$50,000
- 2019 was \$50,000

Schedule "C" in Appendix "A" provides a summary of how the 2019 grant funds were used. For 2020 the Richmond Hill Mobility Accessibility Foundation has requested a grant in the amount of \$50,000. The summary below identifies how the 2020 grant request will support mobility initiatives in the City:

Programs	Amount
Fundraising Program Assistant and Overhead Costs	\$20,000
Assistive Devices Program	10,000
Recreation Programs	20,000
Total Grant Request	\$50,000

Financial/Staffing/Other Implications:

For 2020 the Richmond Hill Mobility Accessibility Foundation has requested a grant in the amount \$50,000. Approval of this amount will leave a balance of \$147,100 in the Disabled Parking Reserve for future mobility and accessibility initiatives.

Relationship to the Strategic Plan:

Providing funding to the Richmond Hill Mobility Foundation is in keeping with the Strategic Plan Goal of Stronger Connections in Richmond Hill and more specifically providing, "opportunities and places for people to connect and get involved" and making, "physical connections in the community". By supporting the Foundation so they may purchase more equipment to aid people with disabilities, the City is assisting in the removal of barriers to effective participation for all people in the community. This funding will also increase accessibility for those people with disabilities.

Conclusion:

That the Richmond Hill Mobility Accessibility Foundation grant request (provided in Appendix "A") be received and that the allocation of \$50,000 of grant funds be
