Amendment of Parking Regulation By-law No. 402-89 Schedule 'E'

Olde Bayview Avenue

Visitors to Lake Wilcox Park are currently parking along the portion of Olde Bayview Avenue adjacent to 80 and 88 Olde Bayview Avenue in order to avoid paying for parking in the Lake Wilcox Park parking lots. The resulting high volume of traffic and parking on this short section of street is generating resident complaints, and also interfering with access to the boat launch to the south which provides emergency boat access to the Lake. Incorporation of this section of Olde Bayview Avenue into the permit parking area in the vicinity of Lake Wilcox Park, will significantly reduce traffic and parking volumes and therefore resolve issues.

In accordance with the above, approval of By-law 114-20 (attached) is requested.

THE CORPORATION OF THE CITY OF RICHMOND HILL BY-LAW 114-20

A By-law to amend Chapter 1116 of the City of Richmond Hill Municipal Code, being by-law 402-89, as amended, relating to parking regulation.

WHEREAS on November 6th, 1989, the Corporation of the City of Richmond Hill enacted a Parking Regulation By-law No. 402-89 (Municipal Code Chapter 1116) that regulates the parking of motor vehicles on public highways and other property;

AND WHEREAS on August 17th, 2020, via Confirmatory By-law No.113-20, the Council of the City of Richmond Hill delegated authority to the City Manager, acting uponconsultation with the Mayor and Ward 1 Local Councillor, to amend Schedule "E" of Parking Regulation By-law No. 402-89, as amended (Municipal Code Chapter 1116), to implement permit parking on public highways near Lake Wilcox;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF RICHMOND HILL ENACTS AS FOLLOWS:

1. That the following be added to Schedule "E" of the Parking Regulation By-law (By-law No. 402-89), as amended:
