3. Scheduled Business

3.1 Discussion regarding the Implementation of Permit Parking on Public Highways near Lake Wilcox

Moved by:Councillor BerosSeconded by:Regional and Local Councillor Perrelli

Whereas, on November 6th, 1989, the Corporation of the City of Richmond Hill enacted a Parking Regulation By-law (By-law 402-89) that regulates the parking of motor vehicles on public highways and other property;

Whereas, Section 23.1 of the Municipal Act, 2001, S.O. 2001, c. 25 (the "Municipal Act, 2001") authorizes a municipality to delegate its powers and duties under the Municipal Act, 2001 or any other Act, subject to those restrictions set out in such Section;

Whereas, Council enacted By-law 86-20, a by-law to delegate certain powers and duties during a recess of Council of the Corporation of the City of Richmond Hill, on June 24, 2020;

Whereas, Council deems it appropriate to amend By-law 86-20 to delegate certain further powers and duties during any period of time in which Council does not hold regular meetings, including that period of time referred to in such as during the summer, prior to an election, or the period referred to in Section 275 of the Municipal Act, 2001 during which the actions that Council may take are restricted;

Therefore be it resolved:

1. That Chapter 1116, being By-law 402-89 of the Corporation of the City of Richmond Hill (the "Parking Regulation By-law"), be amended as follows:

(a) The following street shall be deleted from Schedule "E":

(b) The following streets shall be added to Schedule "E" in alphabetical sequence:

Highway	Side	From	То	Restricted Period
Bayview Park Lane	Both	30 metres North of Sandbanks Drive	Sunset Beach Road	7am-1130pm April 1- September 30
Sylvan Crescent	Both	West limit at Lakeland Crescent	East limit at Lakeland Crescent	7am-1130pm April 1- September 30

- 2. That expect as provided for in paragraph 1 of this resolution, the provisions of the Parking Regulation By-law continue in full force and effect without amendment.
- 3. That Section 2(m) of By-law 86-20, be amended by adding the following paragraph (vi):

(vi) to enact, upon consultation with the Mayor and Ward 1 Local Councillor, a by-law to amend Schedule "E" of Parking Regulation Bylaw 402-89 (Municipal Code Chapter 1116), as amended, to implement permit parking on public highways near Lake Wilcox.
