#### Subject: SRPRS.20.123 – Naming of Parks

#### Purpose:

To receive approval for the names of two new park sites within the City's park and natural heritage system.

## Recommendation(s):

- a) That the proposed name "Private Thomas Armstrong Millar Park" be approved in principle for the site described in staff report SRPRS.20.123;
- b) That the recently approved park name "Private Charles Hill Park" be directed to the site described in staff report SRPRS.20.123;
- c) That the 30-day public input period for the recently approved park name "Private Charles Hill Park" being directed to the site described in staff report SRPRS.20.123 be waived out of respect to the family and in accordance with the City's *Policy for Naming and Renaming Parks, Open Space and Recreation Facilities*;
- d) That the proposed name "Private Thomas Armstrong Millar Park" be advertised on the City's website with request for public comments in accordance with the City's *Policy for Naming and Renaming Parks, Open Space and Recreation Facilities*; and
- e) That staff report back to Council regarding public comments of the proposed "Private Thomas Armstrong Millar Park" and with final recommendations for naming the sites.

#### **Background:**


At its meeting on May 13, 2020, Council directed staff to relocate the name of "Private Charles Hill Park" from the parkette at Rockwell Road, as outlined in staff report SRPRS.19.170 (see Appendix A) and as Council had recently approved, to the parkette on Shining Willow/Petrolia Court. Additionally, Council directed staff to initiate the process to name the new parkette on Rockwell Road, "Private Thomas Armstrong Millar Park".

These proposed names are consistent with the City's *Policy for Naming and Renaming City Parks, Open Space and Recreation Facilities* (see Appendix B) for the two sites within the City's parks and natural heritage system as follows:

#### Pte. Charles Hill Park (Park Class: Parkette)

Location: Ward 5, Shining Willow/Petrolia Court, see Map 1

Private Charles Hill was a resident of the suburb of Richvale at the start of the Second World War. Born in September 1919 to John and Sarah Ann Hill, he enlisted just before his 20<sup>th</sup> birthday with the Royal Regiment of Canada. After his enlistment, Private Hill served in both Iceland and England before making the ultimate sacrifice for his



community and his country as part of the landing group that raided the beaches of Dieppe on August 19, 1942. He is laid to rest in the Dieppe Canadian War Cemetery, located in the village of Hautot-sur-Mer in France.

This report recommends that the 30-day public input period for the recently approved Private Charles Hill Park be waived, out of respect to the family and in accordance with the City's *Policy for Naming and Renaming Town Parks, Open Space and Recreation Facilities* (section 4.4 in Appendix A).

#### Pte. Thomas Armstrong Millar Park (Park Class: Parkette)

Location: Ward 6, Rockwell Road, see Map 2

Private Thomas Armstrong Millar was a resident of Richvale prior to enlisting for World War II. He was born on September 9, 1920 to Thomas Senior and Celia Millar, and married Beatrice Lillian Butler in May of 1940. He enlisted just before his 20<sup>th</sup> birthday with the Royal Regiment of Canada. After his enlistment, Private Millar served in Iceland between June and October of 1940 before making the ultimate sacrifice for his community and his country as part of the landing group that raided the beaches of Dieppe on August 19, 1942. Private Millar has no known grave and is commemorated at the Brookwood Memorial in Surray, England.

The City's *Policy for Naming and Renaming Parks, Open Space and Recreation Facilities* indicates that proposed names be advertised with a request for public comments. Staff will advertise on the City of Richmond Hill's website, seeking input from the public. In accordance with the policy, staff will report back to Council regarding any input on the proposed names received during the 30-day commenting period and make a recommendation regarding final approval of the names.
