
Background:

The park name "Private Thomas Millar Armstrong Park" was approved in principle by Council on September 23, 2020 (SRPRS.20.123 – see Appendix A) for the park at Rockwell Road. In accordance with the City's *Policy for Naming and Renaming Parks, Open Space and Recreation Facilities* (see Appendix B), the proposed name was advertised on the City's website with a request for public comment over a 30-day period. The 30-day commenting period has passed without any objections from the public. Therefore, staff are recommending that final approval be given to the name for the park at Rockwell Road.
