## Background:

The responsibility of a BIA Board, in accordance to the Municipal Act, is as follows:
(1) A board of management shall prepare a proposed budget for each fiscal year by the date and in the form required by the municipality and shall hold one or more meetings of the members of the improvement area for discussion of the proposed budget.
(2) A board of management shall submit the budget to Council by the date and in the form required by the municipality and the municipality may approve it in whole or in part but may not add expenditures to it.

The BIA Board conducted their meetings to establish a proposed budget for 2021.

## Financial/Staffing/Other Implications:

The Village of Richmond Hill Business Improvement Area's 2021 proposed budget is $\$ 127,708$, partially funded $(\$ 27,708)$ by the BIA COVID supplement. The remaining amount of $\$ 100,000$ would be fully funded by a tax levy upon the rateable properties in the area, as part of the final tax billing.

Presentation of the 2021 BIA Proposed Budget reflects the overall use and wise management of resources.

## Conclusion:

The 2021 Proposed Budget of $\$ 127,708$ for the BIA is being recommended for approval with $\$ 100,000$ funding from the tax levy on the rateable properties in the area.
