SUBJECT: Request for Approval using Delegated Authority

Amendment of Parking Regulation By-law No. 402-87 Schedule 'E'

Dariole Drive

On August 17, 2020, via an amendment to By-law 86-20, Council delegated authority to the City Manager to amend Schedule 'E' of the Parking Regulation By-law #402-89 (Municipal Code Chapter 1116) to implement permit parking restrictions on public highways near Lake Wilcox during Council recess periods (including the first two weeks in January).

On October 28, 2020 Council approved a motion, which among other things, was intended to amend the Parking Regulation By-law to facilitate additional permit parking restrictions on Dariole Drive (which is located in the Oak Rides Area near Lake Wilcox). It has just come to the attention of Staff that there was an error in the approved motion that incorrectly alters the intention of the new Dariole Drive restriction. The comment and edit indicated on Item #15.1 (page 46) of the attached Council Minutes describes the necessary correction which needs to be implemented to affect Council's intention (i.e., we need to add another Dariole Drive line to the Parking Regulation By-law, Schedule 'E' table).

In accordance with the above, approval of By-law No. 12-21 (attached) is requested in order to correct the error and clarify the permit parking restrictions applicable to Dariole Drive.

By-law 12-21

A By-law to amend the Parking Regulation By-law No. 402-89, as amended

Whereas on November 6th, 1989, the Corporation of the City of Richmond Hill enacted a Parking Regulation By-law No. 402-89 (Municipal Code Chapter 1116) that regulates the parking of motor vehicles on public highways and other property;

And Whereas on August 17th, 2020, via Confirmatory By-law No.113-20, the Council of the City of Richmond Hill delegated authority to the City Manager, acting upon consultation with the Mayor and Ward 1 Local Councillor, to amend Schedule "E" of Parking Regulation By-law No. 402-89, as amended (Municipal Code Chapter 1116), to implement permit parking on public highways near Lake Wilcox;

Now Therefore, the Corporation of the City of Richmond Hill enacts as follows:

1. That the following be added to Schedule "E" of the Parking Regulation By-law (By-law No. 402-89), as amended:
