Subject: Sole Source Renewal of Agenda Management and Council Live Stream Services

Purpose:

The Information Technology Division is seeking Council approval for a non-competitive acquisition greater than \$100,000, in accordance with the Procurement By-law No.113-16.

Recommendation(s):

- a) That the current contract for the provision of Agenda Management and Council Livestreaming Software previously awarded non-competitively to eScribe Software Ltd. be extended for a term of three (3) years and three (3) months, with two (2) optional one-year term extensions, for a cost not exceeding \$349,000 (exclusive of taxes) pursuant to Appendix "B" Part I, Section (c) of the Procurement By-law No. 113-16;
- b) That the Commissioner of Corporate and Financial Services be authorized to execute any necessary documentation to effect the contract.

Background:

The City of Richmond Hill has leveraged Agenda Management and Council Livestream software by eScribe Software Ltd. since 2017 to manage the Council Staff reports, minutes, agenda and livestreaming functions. The current contract is in its first extension term set to expire on March 31, 2021.

The proposed amendment to the current contract extends the term and includes added functionality for closed captioning services commencing December 21, 2020.Closed captioning is required to meet Ontario's accessibility requirement by January 31, 2021.The estimated amount of the contract value is \$299,000 over five (5) years and three (3) months, with \$50,000 contingency for license growth and potential expansion of services as they become available.

Procurement By-law No. 113-16, Appendix "B", Part I - Sole Source Acquisition clause (c):

- to ensure compatibility with existing products, to recognize exclusive rights such as patent, copyright or license, or to maintain specialized products that must be maintained by the manufacturer or its representative;

The contract extension is recommended to be awarded as Sole Source Acquisition clause (c), because eScribe is the sole proprietor of the software.
