1. Call to Order/National Anthem

The Acting Mayor called the meeting to order at 2:00 p.m.

2. Public Forum (not to exceed 15 minutes)

There were no members of the public who addressed Council during the Public Forum.

3. Council Announcements

Councillor Cilevitz announced that March 8th was globally observed as International Women's Day to commemorate and recognize women's goals and accomplishments. She advised that two Richmond Hill residents Pat Pollock and Deborah Nigra, designed and made a commemorative afghan, along with the contribution of 14 other knitters, to honour the efforts of frontline workers who were active in the community and residents who lost their lives during the

COVID-19 pandemic. Councillor Cilevitz advised that City flags would be lowered at half-mast on March 11 to honour all lives lost due to the pandemic. She described the afghan's unique design, and extended her thanks to Darren Solomon, CEO, Richmond Hill Public Library, for accepting the afghan as a donation to the Library and to having it permanently and publicly displayed at the Richvale Public Library. Councillor Cilevitz extended her appreciation to all women for their notable efforts, and wished all women a Happy International Women's Day 2021.

Councillor West extended thanks to Councillor Cilevitz for her announcement and advised he had the opportunity to see the completed Richmond Hill COVID-19 afghan and noted it was a unique piece of art.

Councillor West announced that on March 21st, he would be hosting a virtual celebration of the 5th annual Ward 4 Maple Syrup Festival between 10 a.m. and 12 p.m. He advised of various activities planned for the whole family and opportunities to win prizes. Councillor West extended an invitation to the community to join him and his family in celebrating spring and participate in the event by registering at DavidWest-RichmondHill.ca/Maple-Syrup-Festival.

Councillor Muench paid tribute to Barnet Kussner ("Barney"), Partner, WeirFoulds LLP, a marathon runner and well known to Members of Council, who suddenly passed away on February 14. He acknowledged his dedication and work for Richmond Hill, and requested that a moment of silence be observed.

A moment of silence was observed by all those in attendance.

Councillor Muench announced that regrettably, the Loblaw store located in the Yonge/Bernard area would be closing and the No Frills would be amalgamating in the area, resulting in job loss in the community. He reviewed the number of grocery stores located at the Yonge/Bernard area, the difficulties for businesses, and outlined the importance of City policies and procedures that help provide choice and opportunities to investors and the community.

Regional and Local Councillor Perrelli provided an update to his successful "Richmond Hill Shop Local" campaign to help promote local businesses in the community. He advised that his office had a limited supply of facemasks available, noted that to-date 9,472 masks were distributed to residents, and that a competition was open to residents to submit photos while wearing their mask in the community to recieve a prize. Regional and Local Councillor Perrelli invited Council to continue encouraging residents to shop local to assist businesses during unprecedented times.

11. Presentations

11.1 Presentation by Ann Marie Farrugia, Manager, Parks Operations, to Acting Mayor DiPaola and Members of Council regarding the City's Tree City of the World recognition

Ann Marie Farrugia, Manager, Parks Operations, made a presentation to Council regarding Richmond Hill being named a "Tree City of the World" by the Arbor Day Foundation, and the Food and Agricultural Organization of the United Nations. She advised that Richmond Hill was recognized and named one of 15 cities in Canada, and 120 cities worldwide to receive the international honour. She reviewed the program goals, and highlighted the City's many approaches, policies and practices in place to maintain a healthy urban forest. She acknowledged the many valued partnerships with businesses, agencies, non-profit organizations, other levels of government, and residents of the community who have helped in the growth of the City's urban forest over many years. A. Farrugia further acknowledged that the international recognition was made possible with the support and direction of Council, and the cross-corporate efforts and dedication of City staff who worked together to maintain the City's urban forest.

11.2 Presentation by John Lanthier, Manager, Media and Brand Partnerships, regarding an Amendment to the Existing Naming Rights Policy - (refer to Agenda Item 13.1)

Mary Anne Dempster, City Manager, provided an overview of the Brand Strategy Naming Rights which began in 2020 and noted the collaborative partnership between the Richmond Hill Public Library and the City of Richmond Hill. She advised that John Lanthier, Manager, Media and Brand Partnerships, would be making a presentation regarding updating the current Council policy and to gain clarity on authority to renaming libraries for consideration.

John Lanthier, Manager, Media and Brand Partnerships, made a presentation to Council regarding the amendment to the Existing Naming rights policy, as outlined in staff report SRCM.21.02. He outlined the recommendations of the staff report and provided a summary of the recommended changes to the policy that ensured the appropriate oversight and clarities remain in place for the City's benefit. He highlighted policy changes and key work underway on brand partnership initiatives, noted the target prospect categories identified so far, and provided a list of facilities where renaming opportunities existed. J. Lanthier displayed various photos of naming conventions that maintained the significance of the facility's original name, highlighted elements of the program, which included fiscal responsibility, strategic approach as a muiti-layer media platform, and indicated the ultimate goal was to generate new and recurring value to all stakeholders involved.

 - (ii) that prior to the amending Zoning By-law being brought forward to a Council meeting for consideration and enactment, confirmation be received that the applicant has registered restrictions over the subject lands under Section 118 of the Land Titles Act;
 - (iii) that pursuant to Section 34(17) of the Planning Act, Council deem that no further notice be required with respect to any necessary modifications to the draft Zoning By-law to implement the proposed development on the subject lands;
 - (iv) that the Plan of Subdivision depicted on Map 6 to Staff Report SRPPI.21.025 be draft approved, subject to the conditions as set out in Appendix "C";
 - (v) that prior to draft approval being granted, the applicant pay the applicable processing fee in accordance with the City's Tariff of Fees By-law.
- b) That Site Plan Control By-law 137-09, as amended, be further amended to include the subject lands within a Site Plan Control Area to implement the proposed development and that said by-law be brought forward to a future Council meeting for consideration and enactment.
