Background:

The Leslie Elgin Developments Inc. Subdivision File 19T(R)-04009 is located north of Elgin Mills Road East and east of Leslie Street and is subject to Phasing as illustrated in Map 1.

On November 21, 2016, Council endorsed Staff Report SRPRS.16.026 (which is included for reference as Appendix 1), which recommended the manner in which additional servicing allocation would be allocated to Leslie Elgin Developments Inc. Subdivision File 19T(R)-04009, which included a portion of this allocation coming through the Region's Servicing Incentive Program (SIP Program).

This program will enable the Leslie Elgin Development Inc. plan of subdivision to qualify for servicing capacity credits which are to be achieved through the registration process of its Phase 2 lands; as anticipated in recommendations of SRPRS.16.026. The program enables water use efficiency and the reduction of wastewater flows from this development by obligating the developer to use high efficiency water fixtures in new homes and on demand hot delivery. In addition the Regions sanitary sewer system construction and flow monitoring requirements will be implemented as part of the delivery of the municipal services for this subdivision.

In order bring this program into effect and enable the additional servicing credit envisaged in SRPRS.16.026 to be assigned, the Region of York requires the execution of a site specific Servicing Incentive Program (SIP) agreement between the Region, the Town and Leslie Elgin Developments Inc, as well as the prepation of a SIP Confomrity Plan which is to be approved by the Region, in consultation with the Town.

Town staff, Region Staff, and Developers respresentatives have been working to finalize the Conformity Plan and to draft the Tri-Party agreement.

At the same time, Development Engineering staff has been working with the developer and their consultant to review and finalize the engineering approvals for Phase 2 of this Subdivision file. However, an executed SIPS agreement will be required before engineering approvals can be granted and a subdivion agreement can be executed. Accordingly, staff recommends that Council authorization be provided to the Mayor and Clerk to execute this Servicing Incentive Program (SIP) agreement between the Region, the Town and Leslie Elgin Developments Inc.; upon the recommendation of the Commissioner of Planning and Regulatory Services and upon the Region confirming their requirements with respect to secutiries and the SIPS Conformity Plan have been satisfied.
