1. Call to Order/National Anthem

The Acting Mayor called the meeting to order at 9:30 a.m.

2. Public Forum (not to exceed 15 minutes)

There were no members of the public who addressed Council during the Public Forum.

3. Council Announcements

Councillor Chan announced that today was National Day of Mourning, a day to remember workers who have suffered work-related disability, disease and death and advised that flags at the municipal offices were lowered at half-mast to observe the day.

Councillor Chan advised that both the federal and provincial government of Canada had declared the month of May as Asian Heritage Month. He stated that the City takes great pride in welcoming diverse cultures into the community, and noted that since the pandemic there had been an increased number of hate crimes towards Canadians of Asian descent. Councillor Chan invited Council to celebrate in the 20th anniversary of Asian Heritage Month to make a strong statement for the City of Richmond Hill not tolerating any hate, crime, behavior, or conduct towards citizens of Asian descent and encouraged Members of Council to participate in any virtual Asian Heritage Month celebrations.

Acting Mayor DiPaola recognized the increase in hate crimes in York Region toward Canadians of Asian descent, acknowledged that the City of Richmond Hill does not condone any acts of hate, and affirmed that the City of Richmond Hill was a strong supporter of Asian Heritage Month.

Councillor West extended appreciation to Acting Mayor DiPaola and Councillor Chan for their acknowledgment of Asian Heritage Month and expressed his support.

Councillor West extended his appreciation to City staff for a successful virtual Earth Day event, and noted the range of information provided and environmental achievements in Richmond Hill by staff and other citizen groups. Councillor West acknowledged staffs advanced technical skill in conducting virtual webinar events during the pandemic.

Acting Mayor DiPaola also acknowledged Earth Day and advised that Arbour Week was an upcoming event, and recognized the City's tree-planting program.

Acting Mayor DiPaola announced that May 1st was being proclaimed as Doctors and Healthcare Workers Day in the City of Richmond Hill, included as Agenda Item 13.8. He recognized how essential our public health efforts and public health workers truly are and extended gratitude to all doctors, healthcare and frontline workers as they continue to provide exceptional work and around the clock care.

Councillor Muench announced that April 28 was dedicated to recognizing all workers who were injured, killed or disabled from occupational illnesses and challenges, and stated that more than 100 countries acknowledge the same. Councillor Muench extended well wishes to all impacted, including doctors and health workers for their continued support.

Elliot Offman, 26 Harmony Hill Crescent, addressed Council regarding the Fence By-law amendment request for 26 Harmony Hill Crescent. He advised that the 8-foot hedgerow at the rear of his property was removed in order to meet the pool enclosure requirements of the Fence By-law and to allow for sufficient setback from the water's edge of the swimming pool. Mr. Offman reviewed staff's assessment of his property as outlined in the staff report, explained the grading of his lands and neighbouring properties, and requested that Council grant a site-specific exemption to permit up to an 8-foot fence to maintain a level of privacy on his property.
