## The Corporation of the City of Richmond Hill By-Law 70-21

A By-law to amend Schedule "A", as amended, being Chapter 1126 of the City of Richmond Hill Municipal Code, relating to the Speed of Motor Vehicles

**WHEREAS** Section 128 (2.1) of the Highway Traffic Act, R.S.O. 1990, C. H.8 (the "HTA") provides that the council of a municipality may prescribe a rate of speed different from the rate set out in Section 128 (1) of the HTA for motor vehicles driven on a highway, or portion thereof, under its jurisdiction;

**AND WHEREAS** Council at its meeting of June 23, 2021 adopted the recommendation in SRPI.21.074 to reduce the maximum speed limit on the roads noted below to 40 kilometres per hour.

## Now Therefore The Council Of The Corporation Of The City Of Richmond Hill Enacts As Follows:

1. That, notwithstanding the general provisions of the Highway Traffic Act, R.S.O. 1990, Chapter H.8, Schedule "A" in Chapter 1126 of the City of Richmond Hill's Municipal Code be amended by adding the following roads:
