#### 3. Scheduled Business

# 3.1 Presentation by David Dexter, Director, Financial Services and Treasurer, and Gary Scandlan, Watson & Associates, regarding the 2021 Development Charges Update

David Dexter, Director, Financial Services and Treasurer, provided introductory remarks regarding the 2021 Development Charges Update and noted this was a follow up to the May 5, 2021 public meeting being held in accordance with the *Development Charges Act*. He explained that the City wide Development Charge (DC) By-law required updating to reflect legislative changes, as well as two area specific By-laws that were expiring in July, and advised that Gary Scandlan, Managing Partner, Watson & Associates, would be making a detailed presentation regarding the update and legislative impact.

Gary Scandlan, Managing Partner, Watson & Associates, highlighted the purpose of this evening's public meeting; reviewed the process used and

timelines associated with the Development Charges Background Study; and provided an overview of Development Charges including:

- Purpose and History;
- Relationship between Needs to Service New Development versus Funding;
- Overview of the DC Calculation;
- Methodology;
- Local Service Policies;
- Service Standards; and
- · Capital Costs.
- G. Scandlan reviewed changes to the *Development Charges Act* since the previous background study in 2019, advised of DC Exemptions and Policies, provided an overview of the history of City-wide Richmond Hill DC's and City-wide services being updated, and reviewed the details of the proposed changes as well as the results of the DC Rate Survey.
- D. Dexter provided an overview of the proposed Area Specific Development Charges for the Bayview North East Development Area and Headford Excluding Storm Development Area, and the financial impact of maintaining current DC rates. He concluded the presentation by advising of upcoming stakeholder consultation meetings and next steps in the process.

Randy Grimes, on behalf of North Leslie Landowners' Group Inc., addressed Council regarding the 2021 Development Charges Update and regarding the memorandum from the Director of Financial Services and Treasurer in response to the correspondence from Michael Melling, Davies Howe LLP, dated May 3, 2021. He advised that he was in support of discussions commencing with the parties to the Minutes of Settlement in June 2021 to address issues that had been identified, and noted that it was not clear whether there would be an inflation/cost increase adjustment in the 2019 capital program to allow for catch-up of inflation that had not been accounted for in the 2019 update. Mr. Grimes requested clarification regarding the historic level of service method and addressed the interest rate applicable to frozen applications.
