Khalid Yusuf, Neuhaus Developments Inc., advised that Neuhaus Developments had been building within the subject neighbourhood for nearly seven years and expressed pride for their work. He noted that the project was intended to be an example of the missing middle, noting that policy planners, the media and politicians had indicated that it was one of the solutions to the affordability crisis. Mr. Yusuf advised of the limited availability of family-sized apartments and options for the elderly, and shared his hope of delivering a project that added to the aesthetic appeal and value of the neighbourhood.
