Subject: Muirhead water and sewer project

The Muirhead Community wishes to address Council on October 27, 2021.

The Muirhead Community has requested Mr. Wayne Emerson to participate in the Council meeting of October 27, 2021.

During the Council Meeting of September 13, 2021, both Ms. Dempster and Mr. Paolo Masaro openly and clearly mislead Council by stating that they had not been contacted nor have heard from York Region, when asked by Council member Carmine Perrelli if they had heard or contacted York Region regarding the install of the Sewer and Water for Muirhead. This development can be verified with the minutes of the September 13, 2021 Council Meeting.

Mr Emerson's email dated October 20, 2020 to Paul Nolis as follows, had been sent to both Ms. Dempster and Mr. Masaro on six (6) separate occasions dating back to October 2020.

This is a local planning and project delivery matter. The Region's infrastructure is in place to support their work.

Ms. Dempster in the Richmond Hill update memo sent to the Muirhead residents (undated) approximately July 2020, clearly indicates Richmond Hill has "paused" the project after spending \$460,000 of taxpayers money on surveys and studies,

The undated update sent to the Muirhead Community of July

2020 also States " BY proceeding, the City could be installing infrastructures that may become obsolete if the development proceeds.

Ms. Dempster in her email, clearly states that rather than providing consumable water to the seniors of Muirhead she directs the seniors of Muirhead to place a claim to the City's notice of claim for disability benefits.and

I quote "I respectfully direct you to the City's notice of claim process, should you wish to make a formal claim <https://www.richmondhill.ca/en/our-services/notice-of-claim.aspx>."

The Muirhead Community is requesting consumable water not disability benefits for drinking inconsumable water, as Ms. Dempster suggested.

Ms. Dempster requested \$100,000.00 from each Muirhead household to reinstate the sewer and water project.

Ms. Dempster was and is fully aware that the majority of the Muirhead Community are seniors surviving on Pension benefits.

Let it be known as an indisputable fact, and clarified no application for development had been sent to Richmond Hill and no developer has expressed interest to pursue development of Muirhead. Contrary to Ms. Dempster position for cancelling the council approved Muirhead water and sewer install despite the 2016 Council approval.

I am requesting that The Richmond Hill Clerk Office ensure that this email from Paul Nolis, and the presentation material attached is to be included on the City website and form part of the package to Council for the meeting of October 27, 2021.

I have forwarded this information to Mr. Emerson, via this email, and requested his participation on October 27, 2021.
