By-Law 102-21

A By-law to amend Chapter 1116 of the City of Richmond Hill Municipal Code, being By-law 402-89, as amended, relating to parking regulation

**WHEREAS** on November 6, 1989, the Corporation of the City of Richmond Hill (the “City” enacted by By-law 402-89 that regulates the parking of motor vehicles on public highways and other property (“Parking Regulation By-law”).

**Now Therefore the Council of The Corporation of The City of Richmond Hill Enacts as follows:**

- 1. That Chapter 1116, being By-law 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended as follows
  - a. Schedule “A” – Parking Prohibited – Signs – Displayed be amended by deleting the below Schedule ‘A’:
