## 11.1 Presentation by Patrick Lee, Director, Policy Planning, and Sybelle von Kursell, Manager, Policy Planning, regarding the Request for Endorsement: Official Plan Update Key Directions - (refer to Items 13.3 and 13.4)

Patrick Lee, Director, Policy Planning, provided introductory remarks regarding the Request for Endorsement: Official Plan Update Key Directions. He advised that the Key Directions Report was to provide guidance for the updating of the Official Plan, and to set the foundation and provide direction to shape the City of Richmond Hill over the next 20 years. P. Lee introduced Sybelle von Kursell, Manager, Policy Planning, who would be presenting to Council additional information and details regarding the Key Directions Report.

Sybelle von Kursell, Manager, Policy Planning, reviewed the purpose of the Key Directions Report, the vision of City Plan 2041, and the pillars of the Official Plan update, explaining the relationship to Council's Strategic Priorities. She advised that the Key Directions were informed by public and stakeholder consultation that included Official Plan Update Committee meetings; open houses; public workshops; online surveys; publications; as well as meetings with prescribed bodies, Indigenous Communities, land owners, BILD, Heritage Richmond Hill, and City staff. She provided a summary of the Key Directions, reviewed the next steps in the Official Plan Update process including who would inform the Key Directions and future Official Plan Amendments, and discussed the consultation that would take place with partners in Phase 3. S. von Kursell concluded the presentation by providing an overview of the recommendations contained in staff report SRPI.21.118.

#### 12. Delegations

12.1 Jeff Dennis, Mount Pleasant Group of Cemeteries, regarding a Request for Notice of Decision for Elgin Mills Cemetery Proposed Niche Building Expansion located at 1591 Elgin Mills Road East -(refer to Item 13.14)

Jeff Dennis, Director Development, Mount Pleasant Group of Cemeteries (MPGC), addressed Council regarding a Request for Notice of Decision

for the Elgin Mills Cemetery Proposed Niche Building Expansion located at 1591 Elgin Mills Road East. He provided background and historical information related to MPGC and the services that they provided to the community, and provided an overview of their request for approval by Council to construct a two-storey addition to the existing Mausoleum and columbarium building at the Elgin Mills Cemetery and next steps in the process, as detailed in his correspondence distributed as Item 13.14.

## 12.2 Pamela Harakh, 66 Major Mackenzie Drive West, regarding the Request for Endorsement: Official Plan Update Key Directions -(refer to Items 13.3 and 13.4)

Harry Harakh, 66 Major Mackenzie Drive West, addressed Council on behalf of himself and his wife Pamela, regarding the Request for Endorsement: Official Plan Update Key Directions. He displayed an area map to show the location of their property and their neighbours, as well as developable lands in the area, to assist in demonstrating their concerns with the Report specifically related to the Summary of Intensification Hierarchy, Land Use Designations, and Alignment with Regional MTSA Minimum Density Targets, and with concepts presented in The Village Local Centre and the impact it would have on them. H. Harakh advised that they were in support of the push for intensification in their area and others, but stressed that transit planning and home planning were corelated.

## 12.3 Wilhelm Bleek, 136 Centre Street West, regarding the Request for Endorsement: Official Plan Update Key Directions - (refer to Items 13.3 and 13.4)

Wilhelm Bleek, 136 Centre Street West, addressed Council regarding the Request for Endorsement: Official Plan Update Key Directions. He advised of his concerns with the Report specific to the location and road of the current City Hall, and expressed his desire to see the city-owned property at the intersection of Major Mackenzie and Yonge Street capitalized upon to bring the municipal administrative building back to a more centralized location, acknowledging past work of the Civic Precinct Project Steering Committee to which he was one of the appointed citizen members.

## 12.4 Allan Ramsay, Allan Ramsay Planning Associates Inc., regarding the Request for Endorsement: Official Plan Update Key Directions -(refer to Items 13.3 and 13.4)

Allan Ramsay, Allan Ramsay Planning Associates Inc., planning consultant retained by the owners of 32, 42, 66, 74 and 76 Major Mackenzie Drive West ("the Neighbourhood Group"), addressed Council regarding the Request for Endorsement: Official Plan Update Key Directions. He noted that the comments provided in his letter dated December 7, 2021, reproduced as Item 13.18, had not been mentioned in the supplementary staff report and there had been no further consultation with staff related to their submission. A. Ramsay advised that they were generally supportive of the Key Directions Report, but requested that their comments and recommendations specific to Major Transit Station Areas, density, and The Village Local Centre, be addressed prior to its adoption as it would be setting the foundation for future planning for the City and its policies.

## 12.5 Martin Abramian, 76 Major Mackenzie Drive West, regarding the Request for Endorsement: Official Plan Update Key Directions -(refer to Items 13.3 and 13.4)

Martin Abramian, 76 Major Mackenzie Drive West, addressed Council regarding the Request for Endorsement: Official Plan Update Key Directions. He noted that he was neighbours with the Harakh's and that the previous delegate, Mr. Ramsay, had been retained as their Planning Consultant and had already identified many of their issues and concerns. M. Abramian addressed two specific concerns that he had with the Report specific to the Major Transit Corridor Areas (MTSA's) and how they would be integrated within the Village Local Centre, and that the unapproved proposal was still showing the extension of Elizabeth Street to the west of his property and needed to be revised. He further expressed his disappointment that the concerns he and his neighbours identified had not been addressed, and hoped that they would be considered moving forward.

#### 12.6 Lauren Capilongo, Malone Given Parsons Ltd., regarding the Request for Endorsement: Official Plan Update Key Directions -(refer to Items 13.3 and 13.4)

Lauren Capilongo, Malone Given Parsons Ltd., planning consultant retained by Parkway Hotels and Convention Centre Inc. ("Sheraton"), owners of land located at the northeast corner of Highway 7 and Leslie Street ("Sheraton Lands"), addressed Council regarding the Request for Endorsement: Official Plan Update Key Directions. She noted that she was before Council in December when this Report was brought forward, and reiterated their request that the Sheraton Lands be identified as a Key Development Area rather than a Local Centre in the Key Directions Report as the Sheraton had a long term vision for the quadrant, as detailed in her correspondence distributed as part of Item 13.18.

## 12.7 John Li, 206 Brookside Road, regarding the Request for Endorsement: Official Plan Update Key Directions - (refer to Items 13.3 and 13.4)

John Li, 206 Brookside Road, on behalf of the Richmond Hill Umbrella Residents Group, addressed Council regarding the Request for Endorsement: Official Plan Update Key Directions. He advised that there was not a proper platform in place for residents to express their concerns and be able to attend interactive meetings regarding planning matters, and suggested that a Committee be established that included resident members to allow large planning matters to be previewed and to allow for participation by all stakeholders.

## 12.8 John Li, 206 Brookside Road, regarding the Member Motion submitted by Councillor Chan regarding Online Voting for the October 2022 Election - (refer to Item 14.3)

John Li, 206 Brookside Road, addressed Council regarding the Member Motion submitted by Councillor Chan regarding Online Voting for the October 2022 Election. He referred to the two successful by-elections held in Richmond Hill during the pandemic that included the option to vote online, noting the increase in voter turnout in the January Mayoral byelection from the 2018 municipal elections, and highlighted area municipalities that have used online voting during elections. J. Li requested that Council consider allowing online voting for the October 2022 elections as it was convenient and reliable, and to give residents the option to vote online.

## 12.9 Blair Peberdy and Doug Fairchild, Alectra Utilities Corporation, regarding Alectra Utilities Corporation (AUC) Hydro Power Supply for Site Plan Application D06-19010 (Urbacon Properties Limited) for 10 Sofia Court - (refer to Item 13.19)

Blair Peberdy and Doug Fairchild, Alectra Utilities Corporation, were in attendance to address Council regarding Alectra Utilities Corporation (AUC) Hydro Power Supply for Site Plan Application D06-19010 (Urbacon Properties Limited) for 10 Sofia Court. D. Fairchild provided background and historical information specific to the Site Plan Application for 10 Sofia

Court, including the proposal to construct a two-storey data centre and warehouse on the land holdings, and discussed their design to supply power to the site located within the Barker Business Park. He noted they attended the residents meetings arranged by the Local Councillor to hear the comments and concerns raised by area residents, and advised they had been working with City staff. D. Fairchild expressed that it was their hope there were no further delays with the project, and requested that Option 4 identified in staff report SRPI.22.038 be approved with respect to the proposed hydro distribution pole line to service the Barker Business Park.

WHEREAS The City of Richmond Hill promotes outdoor activity and recreation this winter with three outdoor public skating facilities and those facilities are so popular they are over capacity; and

WHEREAS members of the public have communicated to and with members of council for more outdoor recreational ice locations; and

WHEREAS the City of Richmond Hill issued a public statement on January 4, 2021 to advise everyone to stay off the lakes, rivers, ponds and stormwater ponds as the ice may not be safe; and

WHEREAS Richmond Hill had at least 1 serious storm water pond safety incident in 2020; and

WHEREAS outdoor ice skating and hockey is a proud Canadian way of life and enjoyed embraced by the young, old and families; and

WHEREAS we are in a COVID time where outdoor recreational is a must; and

WHEREAS many municipalities including Brampton, London, Toronto, Innisfil and Cobourg have prioritized, engaged, advocated and promoted outdoor public skating; including during our COVID period.

THEREFORE BE IT FURTHER RESOLVED:

1. Staff investigate and prepare a report for Council to expand our outdoor ice recreation stock by creating a list for recreation skating with the appropriate budget. This list and budget must also take into consideration, logistics and protocols for at least 1 additional outdoor ice recreation in each of the 6 Richmond Hill Wards for the 2022 / 2023 winter period by July 1, 2022; and

2. Staff and members of Council communicate to members of the Richmond Hill community the need to have community participation, leadership and any and all assistance to assist in the execution and support of outdoor of a vibrant outdoor ice recreation utilization; and 3. Staff in the report to Council have options to have community leadership and participation opportunities similar to our "community club" relationships; and

4. Staff also in the report to Council include the support of private lands to offer outdoor ice recreation in support of our efforts with guidelines, logistics and liability support; and

5. Staff in their report include an area for insurance cost for the city and for the public participation of outdoor ice recreation management, whereby the opportunity and discussion can evolve where members of the public can manage the outdoor ice without liability to the city and protect the public while allowing outdoor ice stock to be increased; and

6. Mill pond ice policy of 12 inch minimum for ice thickness be evaluated to in hopes to get more mill pond ice utilization with safety first protocols not being jeopardized; and

7. A target of a minimum of 10 community "leaders" or "volunteers" must be supporting the outdoor ice recreation in writing; and

8. Staff, provide in the report to Council the opportunities for fundraising including signing options at outdoor ice recreation to help mitigate the cost of providing the facilities while minimizing the cost burden impacting our municipality. The report should include necessary information on how and what is needed in our bylaws to accommodate the capacity of our city to provide increased outdoor recreation facilities; and

9. The staff report should also include any possibility to have expansion of pathways and trails for outdoor ice skating; and

10. The staff report includes creating a committee to include community and local Councillors to support outdoor ice programs and participation.

WHEREAS it is desirable to have a higher turnout rate among voters for the 2022 municipal election to be held in October 2022;

WHEREAS online voting has been demonstrated as the preferred choice of voters in Richmond Hill and helped to result in an increase of turnout rate as it provides a fast, convenient and secure way for voters to cast their ballots at any time without travelling to voting centres;

WHEREAS the City elections team has shown to be capable of conducting online voting competently and effectively in the School Board Trustee By-election in October 2020 and the Mayoral By-election in January 2022; WHEREAS it is deemed advisable to demonstrate Council's commitment to promote a higher turnout rate among voters at municipal elections in support of higher levels of voters' participation in the democratic process;

#### 15.1 Member Motion submitted by Mayor West to Respond to the Infrastructure Ontario (IO) High Tech Transit Oriented Community Plan (Issued December, 2021)

Whereas, Infrastructure Ontario ("IO"), an agency of the Provincial Government, issued the Province's plan for the High Tech Transit Oriented Community ("TOC") in December, 2021; and

Whereas, the City of Richmond Hill has identified four key areas of concern with the IO High Tech TOC plan, specifically:

a. The densities and total population proposed for the High Tech TOC are markedly higher than outlined in the draft RH Centre Secondary Plan (IO High Tech TOC plan anticipates 35,300 to 36,700 residents within the TOC boundary, while the draft Richmond Hill Centre Secondary Plan anticipates 17,700 residents;

b. The lack of alignment with the draft Richmond Hill Centre Secondary Plan vision for mix of use within the High Tech TOC area;

c. The lack of a transparent and fulsome consultation process with Council and residents; and

d. The lack of a financial framework to support the High Tech TOC. and,

Whereas, the public input received by IO on the High Tech TOC plan, during the December, 2021 public consultation period, reflected many of the same issues as the City has noted above; and

Whereas, the City of Richmond Hill has been in on-going discussions with IO concerning the IO High Tech TOC plan issues but, to date, there are key issues yet to be resolved; and

Whereas, the Province is indicating that it is prepared to move to the issuance of a Ministerial MZO by March, 2022 in order to gain certainty for zoning for the High Tech TOC.

Now Therefore Be It Resolved:

That a communication be issued to the Premier of Ontario, with copies to the Minister of Infrastructure, the Minister of Transportation (and others as noted below), that highlights the following:

- The City of Richmond Hill remains committed to supporting the development of the Yonge North Subway Extension (YNSE), and continuing to work with the Province to align the (IO) High Tech (TOC) plan with the emerging Richmond Hill Centre Secondary Plan for this area.
- 2. The City of Richmond Hill is committed to the core principles of the Preliminary Agreement and Transit-Oriented Communities Memorandum of Understanding (MOU) signed by the Region of York and the Province, and the embedded objectives for TOC developments, including:

i. Exchange of Value: Creating new investment and revenue opportunities between the public and private sectors, where possible

ii. Increased Transit Ridership: Develop transit-oriented communities, in which residents choose transit as their first mode of transportation

iii. Improved Customer Experience: Enhancing station areas to make the interaction with customers seamless (e.g., by creating desirable commerce and retail concourses, etc.)

- 3. The City of Richmond Hill has worked with the Province, and is committed to continue working with the Province, to encourage alignment of the IO High Tech TOC plan, to the draft Richmond Hill Centre Secondary Plan, for the High Tech TOC area, with the goal of creating a world-leading urban community and employment hub that is a key destination in the GTA.
- 4. The City of Richmond Hill has a number of concerns about the IO High Tech TOC plan. Key concerns specific to the IO High Tech TOC plan include:

i. The densities and total population proposed for the High Tech TOC are markedly higher than outlined in the draft RH Centre Secondary Plan (IO High Tech TOC plan anticipates 35,300 to 36,700 residents within the High Tech TOC boundary, while the draft Richmond Hill Centre Secondary Plan anticipates 17,700 residents in the High Tech TOC;

ii. The lack of alignment with the draft Richmond Hill Centre Secondary Plan vision for mix of use within the High Tech TOC area;

iii. The lack of a transparent and fulsome consultation process with Council and residents; and

iv. The lack of a financial framework to support the High Tech TOC.

- 5. We join, with the City of Markham, in requesting that the Province provide a 90 day extension, in order to enable the City of Richmond Hill to be able to work through the complicated details related to the IO High Tech TOC proposal and, specifically, the City requests the Province to revise the IO High Tech TOC proposal to address the matters outlined in this motion.

Toronto; City Clerk, City of Vaughan; Toronto and Region Conservation Authority; and, Local MPPs.
