#### **Purpose:**

To establish certain lands as public highway.

### Recommendation(s):

- (a) That the lands forming Part of Lot 27, Concession 2, described as Part 6 and 21 on Plan 65R-39018, be established as public highway to become part of Nannyberry Street;
- (b) That the lands forming Part of Lot 26, Concession 2, described as Parts 3,
  4, 5 and 6 on Plan 65R-3902, be established as public highway to become part of Nannyberry Street;
- (c) That the lands forming Part of Lot 27, Concession 2, described as Parts 1, 2, 3, 22, 23, 43 and 44 on Plan 65R-39018, be established as public highway to become part of Saigon Drive; and
- (d) That the lands forming Part of Lot 27, Concession 2, described as Parts 5 and 23 on Plan 65R-39018 be established as public highway to become part of Prairie Willow Street.

#### **Background:**

The subject City lands are located within the Raki Holdings Inc. Subdivision (Subdivision File 19T-03006) and within the Elgin House Properties Limited Site Plan (D06-15079), which are both located within the North Leslie West Secondary Plan. These developments are located east of Leslie Street and north of Elgin Mills Road East, as indicated on Map 1.

The subject lands are described as Parts 5, 6, 21 and 23 on Plan 65R-39018 and Parts 3, 4, 5 and 6 on Plan 65R-39021, as indicated on Map 2 and Map 3.

These lands have been conveyed to the City as an external conveyance through provisions of the Subdivision Agreement with Richview 19 Holdings Inc. (Subdivision File 19T-12013), as well as through the Site Plan Agreement with Elgin House Properties Limited.

This land conveyance was required in order to facilitate public highway access for the Elgin House Properties Limited Site Plan, and as well as other future development applications in this area, in advance of the Raki Holdings Inc. Subdivision proceeding.

The construction of the municipal servicing and roadworks within the subject lands has been substantially completed, and the timing is now appropriate to establish the subject lands as public highway to become part of Nannyberry Street, Saigon Drive, and Prairie Willow Street, in order to support the issuance of building permits for the Elgin House property.

### Financial/Staffing/Other Implications:

There are no financial or staffing implications arising from this report.
