Background:

The subject development is located at 13351-13359 Yonge Street at the south-east corner of Ridge Road and Yonge Street as shown on Location Map 1.

The Owner of 13351 and 13359 Yonge Street submitted a Site Plan application to facilitate the construction of a medium density residential development (City File: D06-19028). The principal access to the site is proposed through a full movement entrance onto Ridge Road. A secondary access to the loading and garbage area is via a right-in/right-out entrance off Yonge Street.

Through the development review process and a legal title search, it was discovered that there is a 0.3 m reserve block along Ridge Road, extending from Yonge Street to the present east limit of Ridge Road, described as Part 1 on Plan 65R-39767 shown in Appendix A. The 0.3 m reserve block was established along the original north street line of Ridge Road to protect against vehicular access from the then undeveloped lands to the north. Subsequently, a portion of the lands north of Ridge Road, immediately abutting Yonge Street, were expropriated by the Region of York to form part of Yonge Street, Kings Highway No. 11. The remaining 0.3 m reserve is now a remnant strip bisecting the travelled portion of the road allowance currently preventing legal access to Ridge Road from the subject lands.

In order to provide legal access to and from the development lands, via the proposed principal entrance, the 0.3m reserve block described as Part 1 on Plan 65R-39767 should be established as a public highway to form part of Ridge Road.

Financial/Staffing/Other Implications:

The recommendations of this report do not have any financial, staffing or other implications.

Relationship to Council's Strategic Priorities 2020-2022:

The City's establishment of lands as public highway for access aligns with Council's Strategic Priority of Getting Around the City by promoting ease of movement and improving active transportation networks and the function of streets.
