# **Background:**

Each year organizations request permissions to hold special occasion events at various outdoor park locations. The Liquor License Board of Ontario requires a motion from Council approving the request in order for the groups to obtain a liquor license. All groups are required to follow the terms of the City of Richmond Hill Municipal Alcohol Policy and abide by all regulations stipulated by the Liquor License Board of Ontario.

### Financial/Staffing/Other Implications:

All special occasion permit holders pay \$300 per event in accordance with the approved Tariff of Fees By-Law. Revenue is deposited into a Recreation and Culture operating revenue account.

# Relationship to Council's Strategic Priorities 2020-2022:

Enforcement of the Municipal Alcohol Policy and ensuring special occasion permits are in compliance with the rules and regulations of the Liquor License Board of Ontario aligns with Council's strategic priority of a strong sense of belonging specifically by promoting the use of parks and public spaces as places for people to assemble and connect.

## **Conclusion:**

The permit requests for 2022 comply with all regulations set out by the Liquor License Board of Ontario and as outlined in the Municipal Alcohol Policy, therefore staff recommend all requests listed in Appendix A be approved.
