4. Scheduled Business

4.1 SRCFS.21.050 - 2020 Status Report on the 2018-2022 Multi-Year Accessibility Plan – Presentation by Brian Inglis, Legislative and Projects Advisor

Brian Inglis, Legislative and Projects Advisor and Lottery Licensing Officer, made a presentation regarding the 2020 Status Report on the 2018-2022 Multi-Year Accessibility Plan. He advised that preparing and publishing an annual report on the Multi-Year Accessibility Plan (MYAP) was one of the City's obligations under the Accessibility for Ontarians with Disabilities Act (AODA), and was an opportunity to inform the community about specific efforts taken to ensure Richmond Hill was an accessible community.

B. Inglis provided an overview of the Status Report and began by noting that the Acting Mayor had provided an introductory message to highlight a few of the City's key accomplishments. B. Inglis advised that the report was divided into five sections based on the AODA regulations and provided a brief summary of each. The five sections were as follows:

- Accessible Customer Service
- Providing Clear and Accessible Information
- Accessible Employment Practices

- Accessible Design of Public Spaces
- General Accessibility Initiatives

B. Inglis concluded by advising that the final page of the Status Report provided an opportunity for members of the public to provide feedback on the report or accessibility matters in general.
