1. Call to Order/National Anthem

The Mayor called the meeting to order at 9:30 a.m.

2. Public Forum (not to exceed 15 minutes)

There were no members of the public who addressed Council during the Public Forum.

3. Council Announcements

Councillor Beros advised that today was McHappy Day and extended thanks to all of the residents that came out and greeted with him at the McDonald's Oak Ridges location and supported the Ronald McDonald House Charities (RMHC) either through a donation or by purchasing the Ronald McDonald socks. Councillor Beros thanked McDonald's for their work and acknowledged Peter Miller, owner of the Oak Ridges franchise, for his contributions to the community.

Councillor Muench extended congratulations to the Toronto Maple Leafs for their ongoing success, noting the excitement everyone was feeling with their latest playoff win last night.

Councillor Muench advised that he too participated in McHappy Day and encouraged everyone to go to McDonald's today to support the initiative highlighting that a percentage of all proceeds goes towards helping children through the Ronald McDonald House Charities (RMHC), and extended his thanks to McDonald's for being a great community leader.

Councillor Muench noted that the inaugural meeting of the Affordable Housing Strategy Implementation Committee was held yesterday and acknowledged the leadership in addressing the important issue of housing affordability within Richmond Hill.

Mayor West thanked the McDonald's franchise located at Leslie Street and 16th Avenue for inviting him to participate in McHappy Day earlier in the day, and acknowledged the great work that McDonald's does to support various organizations through the Ronald McDonald House Charities (RMHC). In addition, Mayor West gave a shout out to the employees at McDonald's and the work that they do behind the scenes.

Mayor West advised that last night he along with other Members of Council and staff attended the Police Appreciation Dinner at the Sheraton Parkway Toronto North Hotel where retired York Region Police Chief Jolliffe was acknowledged for his years of service, and highlighted ten other awards that were given out honouring acts of bravery, community actions, diversion, equity, and inclusion.

Councillor Chan extended his thanks to the volunteers and staff who participated in the Ward 6 Clean-Up Day that was held this past Sunday, May 1st noting the success of the event despite the rainy weather.

Councillor Chan echoed the comments made by Mayor West regarding last night's Police Appreciation Night.

Councillor Chan acknowledged and extended congratulations to all of the nominees for the Richmond Hill Board of Trade Business Achievement Awards that was held on May 5, 2022.

11.1 Presentation by Altaf Stationwala, President and CEO, Mackenzie Health, regarding an update on operations at Mackenzie Health

Altaf Stationwala, President and CEO, Mackenzie Health, made a presentation to Council regarding an update on operations at Mackenzie Health. He thanked Mayor West and Members of Council for their leadership and ongoing advocacy for the staff at Mackenzie Health, and extended his thanks to the residents for their support throughout the pandemic. He advised that a new Strategic Plan was developed by the Board of Directors and the community with a focus on Patient Care Excellence, People, Growth and Integration; discussed the shift in having the Cortellucci Vaughan Hospital open initially as a pandemic focused hospital before opening as a full service hospital and how that shift assisted the community; and highlighted the integrated approach to healthcare provided at the two Mackenzie Health locations. He addressed patient care at Mackenzie Health during the continued pandemic, including enhanced care provided through technology, and touched on how future growth would be addressed. Mr. Stationwala concluded his presentation by reviewing the proposed refresh and renovations for Mackenzie Richmond Hill Hospital and for the Vaughan Healthcare Centre

Precinct, and advised that they were nearing the end in The Ultimate Campaign and requested continued support to finish the Campaign.

Tung advised that he was available to answer any questions related to the proposed community benefit pursuant to Section 37 of the Planning Act; and related to the correspondence distributed to Council and staff before the meeting from the Canada Mortgage and Housing Corporation (CMHC) acknowledging the ongoing discussions related to a Rent-To-Own program, and advised that all technical matters had been addressed with the development proposal.
