#### The Corporation of the City of Richmond Hill

#### By-Law 58-22

A By-Law to amend Chapter 1116 of the City of Richmond Hill Municipal Code, being by-law 402-89, as amended, relating to parking regulation.

Whereas on November 6th, 1989, the Corporation of the City of Richmond Hill (the "City" enacted by by-law No. 402-89 that regulates the parking of motor vehicles on public highways and other property ("Parking Regulation By-law").
