Subject: Councillor Perrelli's Personal Enviro Day \$139,623.30 Debt

I am a concerned resident in that Councillor Perrelli wants to use taxpayer funds to pay for his personal self promotion Enviro Day blue/green exchange event which took place in 2021. Council Events are required to be funded through sponsorships, and if he didn't collect enough money, it is up to him, not the taxpayers, to make up the shortfall.

Councillor Perrelli said at the time "No tax dollars will be spent for this event. I have raised money from generous donations from the public". Councillor Perrelli did not raise donations to cover his personal event and now wants the City of Richmond Hill to use our tax dollars to pay for it.

On October 13, 2021, Members of Council passed a resolution moved by then Councillor West and seconded by Acting Mayor DiPaola that Council requires Regional Councillor Perrelli to provide full reimbursement to the City for the Enviro Day event such that no taxpayer dollars will be used to cover the amount owing of \$139,623.30.

On June 8, 2022, Councillors Perrelli and Beros are asking Council to approve that Councillor Perrelli is not required to provide any reimbursement to the City for his personal Enviro Day Event.

I am requesting Council to once again require Councillor Perrelli to provide full reimbursement to the City for his personal Enviro Day event such that no taxpayer dollars will be used to cover the amount owing of \$139,623.30.

I request that my written objection be received and recorded as part of the public record with the City of Richmond Hill.
