Subject: Reg Councillor Perrelli's Personal Enviro Day \$139,623.30 Debt and Frozen Account

I am a resident who is VERY concerned that an upcoming motion to council suggests that the debt be forgiven for Reg Councillor Perrelli 's Enviro Day blue/green exchange event, which took place in 2021. Council Events are required to be funded through sponsorships, and if he didn't collect enough money for this event, it should be up to him, not the taxpayers, to make up the shortfall.

Reg Councillor Perrelli said at the time "No tax dollars will be spent for this event. I have raised money from generous donations from the public". Yet, he did not raise donations to cover this event and now wants the City of Richmond Hill to use our tax dollars to pay for it.

On October 13, 2021, Members of Council passed a resolution moved by then Councillor West and seconded by Acting Mayor DiPaola that Council requires Regional Councillor Perrelli to provide full reimbursement to the City for the Enviro Day event, such that no taxpayer dollars will be used to cover the amount owing of \$139,623.30.

On June 8, 2022, Councillors Perrelli and Beros are asking council to approve a motion stating that Reg Councillor Perrelli is not required to provide any reimbursement to the City for his personal Enviro Day Event.

As well, they are asking council to direct staff to unfreeze Reg Councillor Perrelli's expense account.

I wish to state strongly that I hope the majority of council will refuse both actions, and stand firm on ensuring our tax dollars are not used to cover this debt, incurred by Reg. Councillor Perrelli.
