Dear Mayor West and Members of the City Council:

With the allocation of 288 new long-term care beds by the Ministry of Long-Term Care in March 2021, we plan to develop a senior campus in Richmond Hill which includes our 2nd long-term care centre and affordable senior care life lease units.

We have entered into Agreement of Purchase and Sale with Montagna Capital BT Inc. (Montagna) to purchase approximately 5.52 acres of land located at 1577-1621 Major Mackenzie Drive East, Richmond Hill. This block of land is on the southeast side of the site, close to Highway 404. Montagna needs to complete servicing of the site and be ready to sever the land for our acquisition.

It is important for us to secure the land and start planning of the project to meet the high demand of long-term care beds and affordable senior living in Richmond Hill. The rising construction costs have made the situation even more challenging. We have already retained our planner, architect and engineer to start work on the site plan application. As a matter of fact, our planner attended a formal pre-consultation meeting for a site plan application on these lands.

The support from the City of Richmond Hill is greatly appreciated.
