### **Background:**

In April of 2021, Council approved staff report SRPI.21.038, which delegated authority to the Executive Director, Infrastructure and Engineering Services, to approve the assumption of municipal services related to new developments. This also includes assuming road allowances within registered plans as public highway, establishing lands within registered plans as public highway and establishing assumption by-laws. This delegated authority process for assumptions was a recommended outcome from the LEAN review of the City's subdivision assumption process.

As part of delegating authority for assumption of subdivision municipal servicing to the Executive Director, Infrastructure and Engineering Services, it was also recommended that staff report back to Council on a bi-annual basis to keep them informed of the assumptions approved under the new process.

To meet this requirement, the Infrastructure Planning and Development Engineering Division has prepared a summary table of subdivision assumptions approved to the end of Q2 of 2022 under the new delegated authority. This summary is included as Appendix A to this report.

As indicated in the summary table in Appendix A, a total of 5 subdivision files were assumed to the end of Q2 of 2022, which resulted in the City's acquisition of approximately 2.9 km of new municipal roads, 3.3 km of new sidewalks, 5.8 km of new storm sewers, 5.8 km of new sanitary sewers, 2.9 km of new watermains, 2 stormwater management ponds and a sanitary pumping station/forcemain, along with all of the related infrastructure appurtenances.

# Financial/Staffing/Other Implications:

As noted in the summary table in Appendix A, the assumed aboveground and belowground municipal infrastructure will result in an estimated annual operating and maintenance cost of \$74,384.

It is recommended that these operating costs be accounted for in the Public Works Operations Division annual operating budget, as part of next budget cycle.
