Mayor West called the meeting to order at 1:30 p.m.

Statements from Richmond Hill Mayor David West

Mayor West recognized and reflected on the passing of Her Majesty Queen Elizabeth II on September 8th and requested that Members of Council and staff join him in observing a moment of silence.

A moment of silence was observed by all those in attendance.

Mayor West advised that a book of condolences for Her Majesty Queen Elizabeth II was available in the lobby of the Main Municipal Offices located at 225 East Beaver Creek Road for staff and members of the public to sign.

3. Scheduled Business

3.1 Presentation by Gary Scandlan, Watson & Associates Economists Ltd., regarding the Parkland Dedication By-law

Gary Scandlan, Watson & Associates Economists Ltd., made a presentation to Council regarding the City of Richmond Hill's 2022 Parkland Dedication By-law. He advised of the legislative deadline for municipalities to enact a new Parkland Dedication By-law, and reviewed the market analysis including per unit fees enacted elsewhere for medium and high-density units. He addressed the City-wide parkland needs, parkland needs versus potential funding, per unit fee analysis, as well as per unit fee recommendations. G. Scandlan concluded his presentation by providing an overview of Strata Parks and reviewing the recommendations contained in staff report SRPI.22.090.

3.2 SRPI.22.090 - Request for Approval - Parkland Dedication By-law -(Proposed By-law 123-22)

That clause 'b' of the main motion be amended to read as follows:

b) That the Parkland Dedication By-law 123-22, attached as Appendix A to staff report SRPI.22.090, be approved with the following amendments:

General Requirement

4. As a condition of the development or redevelopment of land, the owner of the land shall convey to the City for park or other public recreational purposes:

- a. Two (2) percent of land proposed for development or redevelopment for Commercial or Industrial Uses; or
- b. In the case of land proposed for development or redevelopment for Residential Use, the greater of:
 - i. 5 per cent of the land proposed for development or redevelopment; or
 - ii. 1 hectare of land for each 500 Dwelling Units proposed for development or redevelopment.

Parkland Credits

9. A Strata Park that is conveyed to the City, which conveyance shall be to the sole and absolute discretion of Council, may be considered as contributing toward the parkland dedication requirements set out in sections 4 and 10 of this By-law. The value of the parkland credit given for a conveyed Strata Park shall be 100% of the value of the land required for parkland as this takes into account the inherent use limitations of Strata Parks. Nothing in this By-law shall obligate the City to accept conveyance of a Strata Park or to attribute any value for accessing the Strata Park over non City-owned lands.
