2. Disclosures of Pecuniary Interest and General Nature Thereof

There were no disclosures of pecuniary interest by Members of Council under the *Municipal Conflict of Interest Act*.

3. Scheduled Business

3.1 Education and Training session regarding Stormwater Management Fees

Paolo Masaro, Executive Director, Infrastructure and Engineering Services, provided an overview of stormwater management (SWM), highlighting how development impacted stormwater runoff, the importance of managing stormwater, legislation governing stormwater infrastructure, and the three methods of how it is managed. He also reviewed the anticipated cost of stormwater works that will be considered as part of the 2023 budget deliberations.

Gigi Li, Director, Financial Services and Treasurer, provided a history of how SWM serves were recovered, highlighting the implementation of a SWM fee in 2013 and the limitations of the flat rate structure, and the stormwater rate structure approved by Council in 2020. G. Li provided an overview of stormwater billing in 2022, and advised that the current challenge of the stormwater rate structure was on stormwater only bills. She reviewed the findings of benchmarking research undertaken on stormwater management fees across Canada, and alternative approaches for stormwater only bills to address current challenges.
