### **Purpose:**

- d) That all pending items from the 2018 to 2022 Term of Council (Appendix C to Staff Report SRCFS.23.03), with the exception of items 5 and 6, be deemed closed unless specifically identified by Council; and
- e) That the City Clerk be directed to include items 5 and 6 from the 2018 to 2022 Term of Council Pending Items List, and any other items specifically identified by Council, on the 2022 to 2026 Term of Council Pending Items List.

### **Background:**

The Pending Items List (PIL) is a list of items where Council has made a request for staff reports or where further staff activities are required to be conducted and reported back to Committee of the Whole or Council. Attached are the lists of pending items from the 2010 to 2014 Term of Council (Appendix “A”), 2014 to 2018 Term of Council (Appendix “B”), and 2018 to 2022 Term of Council (Appendix ‘C’). Each PIL includes a summary of the motions and the status of each item as of the September 14, 2022 Council meeting.

For the purpose of providing clarity to Members of Council and the public, the PIL shows items that are in progress, pending completion or have been closed since the last time the PIL was brought to Council; the PIL is brought to Council on a semi-annual basis. The last PIL staff report was brought to Council on May 11, 2022 with the status of each item up to April 13, 2022 (Staff Report SRCFS.22.013).

As this is the first PIL staff report for the 2022 to 2026 Term of Council, staff recommend that all previous items on all three lists be deemed closed except as noted below. Assigning staff resources to continue work identified by previous Council’s reduces the human resources available to address Council’s current priorities. Staff recommend that items 5 and 6 from the 2018 to 2022 Term of Council, and any other items specifically identified by Council, be included on a new clean 2022 to 2026 Term of Council PIL.

### **Financial/Staffing/Other Implications:**

There are no financial, staffing or other implications associated with the recommendation in this report.
