#### 4. Scheduled Business

- 4.1 SRPI.22.017 Richmond Hill David Dunlap Observatory Park Early Priorities Project Update
  - Presentation by Paolo Masaro, Executive Director, Infrastructure and Engineering Services

Paolo Masaro, Executive Director, Infrastructure and Engineering Services, made a presentation to the Committee regarding the Richmond Hill David Dunlap Observatory (RHDDO) Park Early Priorities Project Update. He provided a brief overview of the composition of both the Council Steering Committee and the internal staff Committee; reviewed the Project timeline since the land was acquired in 2008 to highlight progress to date, including the recommendations that arose from the Capital Sustainability Steering Committee specific to the Project; highlighted the Early Priorities for Years 1 to 8; and addressed the capital budget and forecast for the Early Priorities.

- P. Masaro detailed for the Committee current projects and activities broken down by assignment that included:
- Completion of interim trails in December 2021;
- Ongoing design and additional studies for the park entrance and signage, as well as perimeter fencing;
- Construction of the main trail and nature trail in 2022; and
- Scope of work for the Observatory Lane Pedestrian Lane Overpass, site servicing and additional trail work.
- P. Masaro explained the inspiration for the Pedestrian/Cycling Bridge; addressed the ecological restoration for the site which had been broken down into three phases and included Invasive Species Management; and provided a detailed overview of the Heritage Building Restoration, upcoming Facilities work, and Recreation and Culture programming.

Kathleen Graver, Manager, Strategic Communications, presented the Communications approach to the Committee including the goal, strategy and key message for the RHDDO Park. She provided an overview of how staff would be sustaining the message through social media, owned media, media relations, and through a web presence that included a new RHDDO Master Plan page, new tabs on the landing page, and the pages being made more visual. K. Graver concluded her portion of the presentation by advising of the priority for 2022 being the National Historical Site of Canada Plaque Unveiling Ceremony that was being led by Parks Canada which would be in the format of a media event including speeches and a plaque unveiling on stage, and advised the Ceremony was tentatively scheduled to be held the week of June 12th.

P. Masaro concluded the presentation by providing an update on the Radio Shack and Pump House, including staff's recommendations and future budget requests, and reviewing next steps in the Project.

General discussion ensued regarding the RHDDO as a destination park and component of the Yonge and Carrville/16th Key Development Area, and the importance of connection to the area as well as to the park by those wishing to access it; having matters related to the heritage assets of the RHDDO property brought forward to the Heritage Richmond Hill Committee for consideration and for their input as well as by Council; the Building Assessment Report recommendation related to the demolition of the Radio Shack, and what options were available to acknowledge it's historical significance including either the erection of a plague or replicating the structure; the recreation and culture programming at the RHDDO, specifically summer camps, and which buildings they had access to on the property to use; opportunities to utilize the Community Benefit Charge to assist with the construction of the pedestrian rail overpass/bridge; and the benefit to having the interim trails completed to allow members of the public to enjoy the property before the Project has been completed.

Clarification was requested from staff regarding the capital and budget forecast for the Project, how funds from the Community Benefit Charge could be utilized and alternative sources of funding for the Project, how parking would be addressed for the site, and if the final outcome and decisions made related to the Radio Shack would be communicated to the Committee.

Committee members inquired who would be invited to the National Historical Site of Canada Plaque Unveiling Ceremony being organized by Parks Canada, and made their suggestions as to which Committees, community groups and other stakeholders should be considered for inclusion.
